a) Planning Applications - Ref: 1315

Cllr Calderbank raised concerns with the planning process in that any comments raised by the Parish Council are being ignored or supporting documentation not being made available. It was also clear that many residents felt the Parish Council was a planning authority and actively made decisions. The matter was discussed and thought was given to not getting involved in planning matters but on balance the Clerk would raise the concerns with the Planning Manager and seek a meeting for him to address issues raised.

b) Tree removal on Mill View Road and re-planting - Ref: 1316

A tree along Mill View Road was to be removed and replaced. The original location was not suitable and alternative locations were suggested. The Parish Council took no real view on the suggested, alternative locations.
