a) Reports by Lincolnshire Police - Ref: 2719

The Clerk had spoken with the Inspector at Horncastle police station following concerns raised by the parish council. Following a £10 million budget cut roughly 50% of PCSOs have been lost but Wragby will still have adequate police coverage. Residents must report crimes and any crimes will be resourced appropriately. Changes are being made to the crime reporting systems to enable a simple form to be completed which will be received direct by the local policing team.

Further communication would be made with the Police & Crime Commissioners Office.

b) Reports by East Lindsey District Council ward councillors - Ref: 2720

Cllr Yarsley was dealing with grass cutting complaints around Swallow Drive. It was suggested to combine this area within the parish councils remit and discussions will be held with ELDC. She was also dealing with the Police regarding motorcycle noise and inappropriate riding affecting many residents together with extensive driving and crop damage.

a) Development on Millbrook Lane - Ref: 2727

Initial plans of a proposed development, prior to full planning, were discussed. Concerns were raised with regards to school and doctors provisions which would be covered through separate consultations direct with the school and surgery. Consideration would need to be given to traffic particularly on the junction of Millbrook Road and Lincoln Road together with ensuring that existing infrastructure in terms drainage/water/electricity etc coull cope with the additional housing. Provision would need to be made for childrens facilities such as improved play facilities.
