Cllr Platt was not in attendance due to technical difficulties.



8010 - Safety Barriers To Dyke Along A158 Between Poachers Close & Milbrook

Lincolnshire County Council had confirmed that they were not responsible for this fencing and upon completion of such developments the responsability normally passed tot he parish council. It was also likely that the fencing was installed for aesthetic reasons by the developers.

The Clekr had instructed the handyman to price up replacing or repairing this fencing.

8564 - Glass Re-Cycling Bin In Wragby

No progress had been made due to Coronavirus restrictions.

8565 -- Community Speedwatch

Adverts had been placed on the web site, social media and notice boards seeking volunteers.

A minimum of six were required to commence the scheme. So far we have 4 volunteers.
