Cllr Bradwell provided an update including updates on Mill Road resurfacing, starting the process to place the bridleway from Horncastle Road running parallel to Manor Drive onto the definitive map and planning complaint in respect of Gleesons development. She also confirmed the proposed crossing on Louth Road, near the mini roundabout would be a Zebra crossing. Cllr Watts asked if the loose gravel resulting from patching up the surface of Mill View Road could be removed as it was being thrown across the footpath by vehicles, creating a hazard for pedestrians. Cllr Dalby asked if the damaged bollard on the RHS at the entrance to the Market Square could be attended to. It had been reported much earlier in 2020 but no action had yet been taken. Someone also raised the matter that the white line road markings at the traffic light crossroads needing repainting.


