Old and damaged barriers have been removed. to tidy the area up. A claim has been submitted to the contractors for damage caused and had yet to be settled. Replacement would be reviewed throughout the next few months.

8564 - Glass re-Cycling Bin In Wragby

ELDC contractors had completed a successful site visit for the proposed site near the fire station. Land owners had now been approached for permission to site and awaiitng feedback.
